Jackie Killeen is Director, Scotland of the British Council, the UK's international organisation for cultural relations and educational opportunities. Jackie's remit is to develop opportunities, connections and relationships between Scotland and the wider world.



She was previously Director, Scotland for the Big Lottery Fund setting the Fund's strategy and leading its operations in Scotland. She has an extensive background in social policy and funding. Currently a board member of arts charity Culture Republic, she has been involved in several voluntary organisations.

Theresa Shearer @Theresa_ENABLE

Theresa Shearer is Chief Executive of ENABLE Scotland, a leading learning disability charity and a trustee of SCVO, as well as a number of other charities, including Impact Arts and Key Trust.



Theresa recently led the Scottish Fundraising Working Group, on behalf of Scottish Government, which was tasked with sector wide and public consultations to determine the most appropriate method of fundraising regulation in Scotland. A model of fundraising regulation with enhanced roles for both charities and the Scottish Charity Regulator is now being implemented, based on the recommendations of this group.

Louise Macdonald OBE @Louisemac

Louise has been Chief Executive of Young Scot for seven years, and prior to that had a varied career in the public sector, specialising in youth volunteering and community enterprises, including establishing a pioneering national programme to promote volunteering and social action.



Louise is Vice Chair of the 2020 Climate Group; a committee member of the Institute of Directors in Scotland and a Board member of the Scottish Parliament "think tank" Scotland's Futures Forum. She was awarded an OBE in the New Year's Honours List in 2015, and in 2016 she was named Female Director of the Year by IoD Scotland, and Third Sector Director of the Year by IoD UK.

Board Self-Assessment: A Continuous Improvement Approach

Neil McLean, Social Enterprise Academy

Disagreements between Board members? Volunteers and employees not seeing eye to eye? Personality Clashes? Partnership and collaborative working proving difficult?

Mediation involves an independent third party assisting people to identify and express what their issues are and then work together to find a solution. This discussion will show you how mediation can resolve difficult situations in your organisation.

Social Media Fundamentals Ross McCulloch, Third Sector Lab

Ross will look at the importance of a simple social media strategy focused on creating content that users will engage with. We'll explore how to understand which online channels



to use, how to find out which types of content your users will find interesting or useful and how you can measure success. Ross will look at real-world content examples, exploring a range of channels including Facebook, Twitter, Instagram, Snapchat, LinkedIn, blogging, video and audio.

Trading by CharitiesAndrew Kayley, HMRC



Many charities trade either as part of their charitable activities or to raise funds, this discussion will cover what the tax implications of trading activities are for charities? Andrew will look at: what charitable trades are permitted, what happens if charities carry out non-charitable trading, the small trading tax exemption and many other frequently asked questions.

The Treasurer's Survival Toolkit Kirsty MacKenzie, iMultiply

The level of skill required by treasurers will vary dependent upon the size of the charity and the complexity of the financial transactions; however, there are a number of core skills common to all. This discussion session will cover these skills, but also give you a good idea about where to look when you need more information.

Some of the skills covered will be: organising the finances of the charity, monitoring the controls of financial records, analysing and evaluating financial information, communicating finance to non-finance people, and, perhaps most importantly, ensuring that all trustees know that they have a shared responsibility for the financial health of the charity.

The Trustee as a Fundraiser: How Hands-On Are You? Catriona Reynolds, Arts and Business Scotland

As well as a strategic role, trustees are sometimes expected to have a more hands-on role in relation to fundraising. This discussion will give you the opportunity to understand what may be expected of your trustees, and will look at some of the ways that they can get involved, particularly if they have not had to do so before.

Trustee Induction: Start As You Mean To Go On Tracey Bird and Rhonda McLean, SCVO



A good induction is vital for new trustees so they can learn how to carry out their responsibilities and know what support they can expect. It should ensure that each new trustee can play a full part in discussion and decision making, and set the groundwork for future development and learning. This session will look at what an induction should include, and give you the opportunity to share your own experiences – good and bad.

TSIs and How We Support You

This discussion will be led by officers from Third Sector Interfaces involved in supporting the governance of local charities and third sector organisations.



We will highlight the role of Third Sector Interfaces in supporting trustees; and involve delegates exploring their own role in relation to a charity's governance. We'll consider principles of good charity governance and explore what helps in being a good trustee and what works well for delegates own boards when governing their organisation.
